



An overview of the subsidy jungle

Sustainable construction and renovation not only make ecological sense, they are often also financially supported by subsidies. In Switzerland, there are extensive public and alternative funding programs.

Climate strategy and the real estate sector

In order to achieve its climate targets, Switzerland faces the challenge of improving energy efficiency and reducing CO2 emissions. The importance of modernizing Switzerland's building stock is reflected in greenhouse gas emissions – the real estate sector is the second-largest emitter in Switzerland with a share of around 26%¹.

Subsidies as an incentive

Switzerland relies on research, innovation and a wide range of funding instruments to promote the energy-efficient renovation of properties. These include investments by the public sector (federal, cantons, municipalities) as well as private institutions.

Subsidies are provided for both renewable energy generation and energy efficiency. The amount of funding depends on various factors, including the location of the property, planned renovation measures and the desired building certificates, and in some cases varies greatly between cantons.

Complexity due to the range of programs

The large number of funding programs and incentives for the energy-efficient renovation of properties and their different and complex structures requires extensive consideration.
